Considering the above I agree to report to SODRAC any assignment of rights granted on the date of signature hereof specifying the work's title, date of creation and the assignee of rights.

In accordance with By-Law No. 2 concerning Restrictions on member Contributions, I wish to be consulted on any requests pertaining to the use of my works or of the works on which I hold copyright, for the following:

- Any use for advertising purposes;
- Monographic publications as well as audiovisual and multimedia productions (including Websites);
- Catalogues raisonnés;
