In certain cases, the artist or the right owner(s) of the artist's estate may require a PDF layout, printer's proof or prototype before authorization can be obtained from SODRAC. Therefore, additional time should be allowed for licensing.

GENERAL TERMS AND CONDITIONS

Authorization must always be obtained prior to the use of any artwork. Authorizations becomes effective only when all applicable conditions have been met and SODRAC has received 2 signed copies of the license and full payment of the invoice. Any reproduction for which the related rights have been paid without meeting the other conditions shall be deemed illicit and shall authorize SODRAC to exercise its rights as a consequence thereof. A countersigned copy of the license will be returned to the Licensee for their files.

1. Copyright by-line

The name of the artist, the title and description of the artwork and the mention "© *Name of artist or Estate of name of artist* / SODRAC (year)" must appear as close as possible to each reproduction prior to the mention relating to the photographic materials. The specific by-lines will be provided to you once your request has been approved by SODRAC.

2. Sample copies

Two copies of each version of the publication or product that is the subject of this application must be provided to SODRAC as soon as the publication/product is printed and prior to the initial public distribution.

3. Intuitu personae

All reproduction authorizations are granted on a personal basis only and may not be assigned to a third party without SODRAC's express and prior approval.

4. Reproduction conditions

Unless SODRAC specifically authorizes otherwise, artworks must be reproduced in their entirety and without modification. This condition excludes the overprinting of text or of any other element that is foreign to the artwork, the manipulation, fragmentation or deconstruction of artworks or their use as icons which is strictly prohibited. In all cases, reproductions must be made from high-quality photographic materials and the colours must be true to the original artwork. The reproduction of details is permitted only if the artwork in question is also presented in its entirety and the mention "detail" follows the title of the artwork. Cover reproductions (front / back / inside), merchandise, promotional material, and internet home page reproductions **require the artist or estate's approval of a PDF layout prior to authorization**, in which case an additional delay must be anticipated.

5. Administration fees

The cancellation of any issued license is subject to administrative fees of 50\$ (plus taxes) or more, depending on the work carried out. In the absence of the exact copyright by-line, payment of royalties, delivery of sample copies, or for the use of a work without authorization, or for the inclusion of works not previously authorized, an amount equal to that of the royalties due will be invoiced and payable by the user.
